Drinking Water Quality Regulator for Scotland



GUIDE TO INFORMATION AVAILABLE THROUGH OUR PUBLICATION SCHEME

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities, including Drinking Water Quality Regulator for Scotland (the 'Regulator') to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available
- tell the public how to access the information and what it might cost.

The Regulator has adopted the Model Publication Scheme produced by the Scottish Information Commissioner. You can see this scheme on the Regulator's website at www.dwgr.scot or by writing to the address below.

The purpose of this Publication Scheme is to:

- allow the public to see what information is available (and what is not available)
- state what charges may be applied
- explain how to find the information easily
- provide contact details for enquiries and to get help with accessing the information
- explain how to request information she holds that has not been published

Availability and formats

The information the Regulator publishes through the model scheme is, wherever possible, available on his website. The Regulator can offer alternative arrangements for people who do not want to, or cannot, access the information online or by inspection at his premises. For example, it is usually possible to arrange to send information to you in paper copy (although there may be a charge for this).

Exempt information

The Regulator will publish the information held that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example, sensitive personal information or commercially sensitive), this information will be removed or redacted before publication.

Charges

This section explains when the Regulator may make a charge for publications and how any charge will be calculated.

There is no charge to view information on the website. The Regulator may charge for providing information to you e.g., printing, photocopying and postage, but this charge will be no more than it actually costs to process your request. The Regulator will always tell you what the cost is before providing the information to you.

The printing and photocopying charge per sheet of paper is shown in the table below:

Information provided on CD-ROM/DVD will be charged at 50p per computer disc. Postage costs will be recharged at the rate paid to send the information to you. When providing copies of pre-printed publications, the charge will be no more than the cost per copy of the total print run. The Regulator will not pass on any other costs to you in relation to her published information.

Please note that this charging schedule does not apply to our commercial publications (see Class 8 below). These items are offered for sale through retail outlets such as book shops, academic journal websites or museum shops and their price reflects a 'market value' which may include the cost of production.
